CALL TO ORDER: 1:30 p.m. by Chair LaHair.

- I. ROLL CALL: Deputy City Recorder Marshall. Absent: Keener Mallicote. Chair LaHair welcomed Mr. McKinley and asked him to introduce himself to the board.
