A. NEW PERMITS.

1. **Jay Goga 3 Inc.** Mr. Jigneshkumar Patel, Owner, provided information on this new business. He stated their POS system would scan the ID for anyone purchasing alcohol and that he understood the hours he could sell beer. He confirmed for City Attorney Billingsley it was a retail establishment. Planning Manager Weems reported no zoning issues and Chief Phipps confirmed no problems with the background check.

To issue an Off-Premises Beverage Permit to **Jay Goga 3 Inc.** for the **PJ Smoke Shop** located at 4528 West Stone Drive, Suite #3, Kingsport.

2. **Jay's Place.** Mr. Jay Joseph, Owner, provided information on his restaurant, noting he opened in August and patrons had been requesting he serve beer. He stated he is just open a few hours a week but might extend hours in the future and will notify the city clerk. He further stated they will card everyone who purchases beer. Lastly he inquired about outdoor seating. Planning Manager Weems explained the process for this and reported no zoning issues. Chief Phipps confirmed no problems with the background check.

To issue an On-Premises Beverage Permit to **Jay's Place** for the **Jay's** restaurant located at 115 Broad Street, Kingsport.
