 - **B. ADOPT A PUBLIC COMMENT POLICY.** City Attorney Rowlett provided information stating a public comment section will be a required addition to the agenda beginning July 1st per state law. Mr. Rowlett presented language to be added to Section II.C.3 "Public Comment" and the addition of Section II.D to address this issue. There was some discussion regarding the wording of the new section and the board approved the following: "Individuals may speak on agenda items or matters relevant to Chapter 6 of the Kingsport Code of Ordinances. Individuals who wish to speak will stand before the board and prior to making comments state their name, address, and if provided sign the register. An individual's comments shall be limited to three minutes in duration and an individual may only speak once during the public comment period. A total of thirty minutes will be allotted for public comments. Individuals who are not applicants for a permit and who wish to speak about an application for a permit must do so during the public comment period."
 - **C. JULY BUSINESS MEETING.** Discussion ensued regarding the meeting which is regularly scheduled to be held on the July 4 holiday. City Clerk Marshall stated currently there are no applications on the horizon, but the board decided they would have a called meeting on July 11 if necessary.
