**On or about** March 18, 2025 **the** City of Bristol, Tennessee as Lead Entity for the Northeast Tennessee / Virginia HOME Consortium **will submit a request to the U. S. Department of Housing and Urban Development (***HUD)* **for the release of** Northeast Tennessee / Virginia HOME Consortium funds under Title II of the Cranston-Gonzalez National Affordable Housing Act, 1990, as amended, to undertake a project known as Kingsport Consortium Project for the purpose of substantially rehabilitating a single-family residential unit for the existing homeowners. The project includes approximately \$50,000 in Northeast Tennessee / Virginia HOME Consortium funding. The substantial rehabilitation project is located at 3314 Hillcrest Drive.

**The activities proposed** are categorically excluded under HUD regulations at 24 CFR Part 58 from National Environmental Policy Act (NEPA) requirements. ## **ENVIRONMENTAL CERTIFICATION**

**The** City of Bristol, Tennessee as Lead Entity for the Northeast Tennessee / Virginia HOME Consortium certifies to HUD that Kelli Bourgeois in her capacity as City Manager consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the *Northeast Tennessee / Virginia HOME Consortium* to use Program funds.

## **OBJECTIONS TO RELEASE OF FUNDS**

HUD will accept objections to its release of fund and the *City of Bristol, Tennessee's* certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases:

(a) the certification was not executed by the Certifying Officer of the *City of Bristol, Tennessee as Lead Entity of the Northeast Tennessee / Virginia HOME Consortium;* 

(b) the City of Bristol, Tennessee as Lead Entity of the Northeast Tennessee / Virginia HOME Consortium; has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58;

(c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by *HUD*; or

(d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.
